

Ethics Training: Kaiti Lenhart, Supervisor of Elections

Legislation passed in 2013 requires all Constitutional Officers to complete four (4) hours of required training each year on the State's Code of Ethics, the Sunshine Law (public meetings) and Public Records. The intent of this legislation is to ensure Constitutional Officers are aware of the legal requirements so they can be applied to their public service and agencies throughout the state of Florida.

Section 112.314(2)(a), F.S.: All constitutional officers must complete 4 hours of ethics training each calendar year that addresses, at a minimum, s. 8 Art. II of the State Constitution, the Code of Ethics for Public Officers and Employees, and the public records and public meetings laws of this state. This requirement may be satisfied by completion of a continuing legal education class.
