## ★ SPECIAL ELECTION FOR STATE SENATE, DISTRICT 1 ★

THE STATE OF FLORIDA HAS CALLED FOR A SPECIAL PRIMARY ELECTION TO BE HELD FOR THE OFFICE OF STATE SENATE, DISTRICT 1. REGISTERED AND ELIGIBLE VOTERS WHO RESIDE IN PRECINCTS 1, 3, 4, 5 AND 18 MAY VOTE IN THIS ELECTION.

### SEPT 20 September 20, 2011 SPECIAL PRIMARY ELECTION

#### REGISTRATION BOOKS CLOSE ON AUGUST 22, 2011

Persons who are not registered to vote or who wish to change their party affiliation must do so by August 22, 2011.

#### MAIL (ABSENTEE) BALLOT INFORMATION

Any registered and qualified voter in Flagler County may vote by absentee ballot. You may request an absentee ballot in person, by mail, online or by telephone. You must provide your name, address, date of birth, address to which the ballot is to be mailed and signature (if written request). Please be aware that absentee ballots are not forwarded by the postal service, so you must provide the address where the ballot should be mailed at the time of your request. The absentee request deadline is **September 14, 2011** for the Special Primary Election and **October 12, 2011** for the Special General Election.
