REGISTRATION BOOKS CLOSE ON JULY 16, 2012

Persons who are not registered to vote or who wish to change their party affiliation must do so by July 16, 2012.

NOTICE OF CHANGE OF PRECINCTS

Due to redistricting, each voter in Flagler County will receive a new Voter Information Card during the month of June with updated district numbers and precinct locations. When you receive your new Voter Information Card, make a note of any precinct change and destroy your old card. You must vote in your NEW ASSIGNED PRECINCT on Election Day. The mailing will include a Sample Ballot for the August 14, 2012 primary election.

MAIL (ABSENTEE) BALLOT INFORMATION

Any registered and qualified voter in Flagler County may vote by a mail ballot. You may request a mail ballot in person, by mail, online or by telephone. You must provide your name, address, date of birth, address to which ballot is to be mailed and signature (if written request). Absentee ballots are not forwarded by the U.S. Postal Service, please provide the correct mailing address at the time of your request. Primary election mail ballot request deadline is **August 8, 2012**.

HAS YOUR SIGNATURE CHANGED?

It is important to keep your signature current with the Elections Office. This enables us to validate your signature on a mail ballot and/or candidate and initiative petitions. If your signature has changed, you may update your signature by completing the Florida Voter Registration Application and returning it to the Elections Office. Signature updates can be made anytime.

EARLY VOTING • PRIMARY ELECTION

Any registered and qualified voter in Flagler County may vote early August 4 - August 11, 2012 according to this schedule.
